He is the author of Literature Suspends Death: Sacrifice and Storytelling in Kierkegaard, Kafka and Blanchot (Continuum, 2011) and the co-editor of Strong Opinions: J. M. Coetzee and the Authority of Contemporary Fiction (Continuum, 2011). Ronald M. Green is the Eunice and Julian Cohen Professor for the Study of Ethics and Human Values in the Department of Religion at Dartmouth College.
